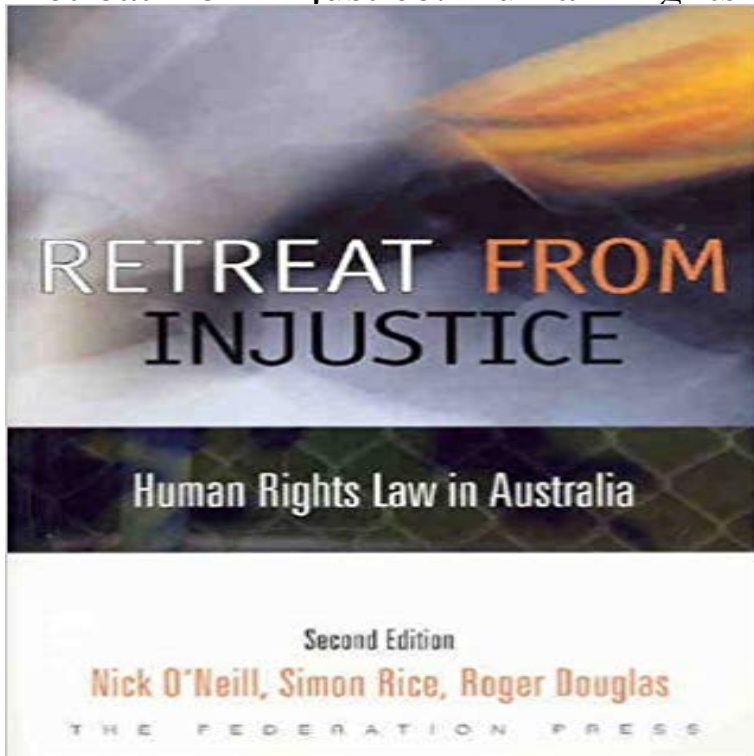


Retreat from Injustice: Human Rights Law in Australia
