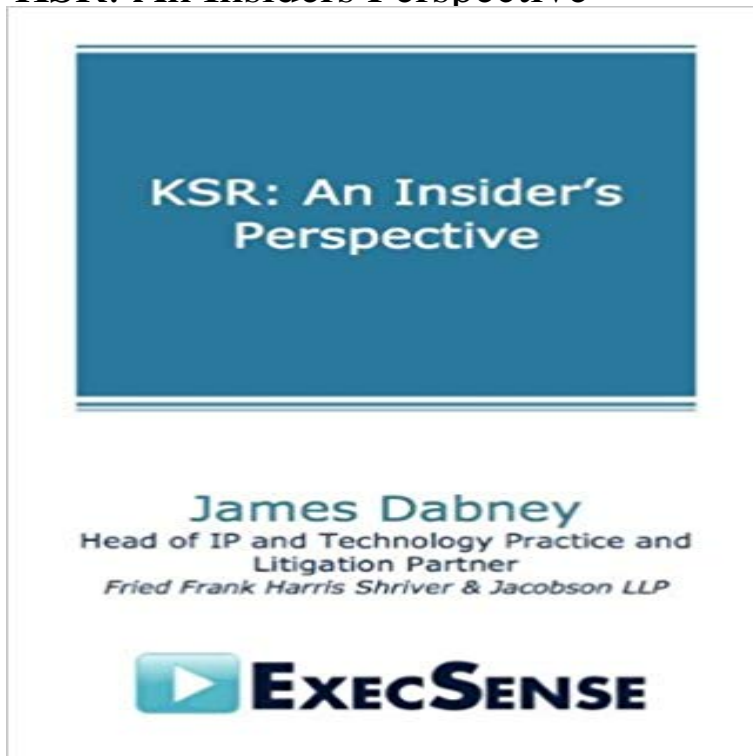


## KSR: An Insiders Perspective



KSR v. Teleflex is best known as a Supreme Court decision that reinvigorated 103 of the Patent Act. But KSR also holds important lessons for the cost-effective handling of patent litigation in general. In the district court, for example, KSR was able to avoid costly and, as is turned out, unnecessary claim construction exercises by urging the district court to assume, for purposes of argument, that words used in asserted claims had the meaning that the plaintiffs argued they had for purposes of determining whether the asserted claims could be valid on that assumption. Phrasing patent litigation in this way has enormous cost-reducing potential. The KSR decision expanded the adjudicatory authority of federal courts and the United States Patent and Trademark Office (PTO). Prior to KSR, federal courts and the PTO had been said to lack authority to invalidate claims under 35 U.S.C. 103 in the absence of a proven teaching, suggestion, or motivation to make particular claimed subject matter. After KSR, a proven teaching, suggestion, or motivation to make particular claimed subject matter remains one basis on which a judgment of invalidity may rest, but courts and the PTO may now also invalidate claims on multiple other grounds such as where claimed subject matter involve[s] ... the mere application of a known technique to a piece of prior art ready for the improvement. 550 U.S. at 417. KSR also suggests that persons accused of patent infringement have a right to independent judicial, as distinct from a lay jury, determination of whether subject matter claimed in a patent is non-obvious as a legal matter.
